ANNUAL REPORT

The Annual Membership meeting of the American Border Collie Association, Inc. was held on September 28, 1996 in Lexington, KY during the USBCHA National Finals. Mike Hubbard welcomed all members and guests. There were 1,148 eligible voting members for 1996 and with the 279 eligible ballots returned and those present for the meeting a quorum was present. The minutes of the 1995 Annual Meeting were read and approved along with the Financial Statement for 1996. Registration and membership reports were distributed. It was announced that we currently have over 85,000 dogs registered and over 7,900 members.

There was discussion about the low use of promotional funds by some states. Again the newsletter will include reminders about the money available and members would be encouraged to use their state's money to help promote the Border Collie.

During the Handler's Finals a total of \$12,195.20 was paid to the top 50 and top 20 handlers and other winners as well as \$1,000.00 paid to the breeders of the top Open and Nursery ABCA registered dogs. Florence Wilson of Gordonsville, VA was the winner of both Breeder's checks. Congratulations to all participants and winners!

It was also announced that the Register on Merit Program was completed and available for members to use.

The results of the election were announced and the new Directors elected to serve 3-year terms were: Patrick Shannahan, Idaho; Sally Lacy, Connecticut; J. P. Lalonde, Ontario; and Roger Schroeder, California.

Amanda Milliken then reported on the status of ABCA Canada. She stated that they had completed the legal process of incorporating, etc., and that they were in the process of negotiating a fee schedule with the Board of Directors of ABCA.

ABCA REGISTRATION POLICIES

A few of our members are still confused about our policies since Kennel Clubs started registering Border Collies and showing them in the "Show Ring." This was done over the objections of the majority of Border Collie people. Since the beginning of the Border Collie breed, the Border Collie has had it's own registries in which Border Collie people made decisions about the breed. The main goal behind the development of the breed is that it should be selected for what it does, not for what it looks like.

Kennel Club policies of selection for looks, by giving championships to dogs in the show ring, is a major break from the tradition of selecting the dogs for their performance. Policy was set by the Board of Directors of the American Border Collie Association, Inc. that they would not accept any dogs with any ancestor that is registered with a registry that promotes conformation showing. The Board of Directors set this policy to uphold the memberships' need for a registry of "Working Border Collies." If a dog or any of it's ancestors is registered with a registry that promotes selection for looks, it may still request registration through the Register on Merit Program which will allow proven "working" Border Collies back into the gene pool of the American Border Collie Association, Inc.

There was then extensive discussion about the notation of eye certification on the registration forms. It was explained that the program had not been completed to properly operate with the stipulation that it was only good for two years and would need to expire on the two year anniversary date of the test. The computer consultant would again be contacted to determine the status and request a quick resolution.

There was some discussion and questions about the registry publishing a stud book much like ISDS does. It was explained that the cost was almost prohibitive and that there seemed to be few people that might actually be interested in paying the high cost of the publication.

There being no further business the meeting was adjourned.

ANNUAL DIRECTORS MEETING

Following the Annual Membership Meeting, the Board of Directors of the American Border Collie Association met. Officer elections were held. Dr. Leroy Boyd was elected President; Dave Arnold, Vice-President; and Patty Rogers, Secretary/Treasurer.

The Executive Committee was also elected and Florence Wilson, Patrick Shannahan and Roy Brown would serve for the 1997 year. New members to the Board were welcomed and updated on the business of the registry.

Dr. Boyd will be appointing new committees in the near future and their work will begin. Committee reports will be forwarded to the membership in the next newsletter.

REGISTER ON MERIT PROGRAM

for the

American Border Collie Association, Inc.

Application requests and all documents must be filed with the Secretary through the ABCA Office.

ALL of the following conditions, one through six, **MUST** be met:

1. A pedigree of the dog should be supplied to the Secretary, giving all details available on the sire and dam, including registration numbers when available.
2. Confirmation by a Board Certified Veterinary Ophthalmologist that both sire and dam have been PRA / CEA tested and passed clear and have received "good" rating from OFA on their hips. (This condition may be impractical or impossible to meet in some cases. The ROM Committee has the authority to wave this condition in some circumstances.)
3. Confirmation that the dog seeking registration on merit has attained a minimum age of two years and has been certified to be clear for PRA / CEA by a Board Certified Veterinary Ophthalmologist within 30 days prior to date of application. The dog must also receive at least a "good" rating from OFA on his/her hips.
4. Fee: \$100 non-refundable. The applicant will also be required to bear whatever cost may be incurred by the committee to meet the eligibility requirements.
5. A video of the dog working livestock must be supplied to each member of the ROM Committee. That Committee will make a recommendation whether to refer to the full Board of Directors or not. If referred to the full Board, a video of the dog working livestock must be supplied to the rest of the Directors unless some of them have seen the dog and do not need a video.
6. The owner of the dog requesting registration on merit must be a member in good standing of the American Border Collie Association, Inc.

Working Qualifications

(One or the other of these options must be met:)

1. Written proof that the dog seeking registration on merit has placed in the top 10% of three open, advertised National style and size trials judged under ISDS or USBCHA rules.

or

2. To pass the working qualifications, the dog must demonstrate outstanding abilities in outrun, lift, fetch, driving, and must satisfy the Directors as to his good balance, power, and eye. At least three of the Directors must see the dog in person working livestock at a place other than his home on livestock that he is not used to.

In all cases, at least three Directors must see the dog seeking registration on merit and 11 of the 12 Directors must vote to approve the dog for registration.
