ANNUAL REPORT

The Annual membership meeting of ABCA was held on September 26, 1997, in Klamath Falls, Oregon, in conjunction with the National Finals Trial. Dr. Leroy Boyd, President, welcomed all members and guests and recognized Charlie Errington, President of USBCHA, Bob West with Purina, Dr. Aclund from Cornell University and his assistants-Melissa Demille and Denise Wall, and Kate McCusker and Mike McLeod with Bye 'N Away Productions. There were 1925 eligible voters for 1997 and 396 had returned their ballots which established a quorum for the meeting. Hope Hanson, Beverly Lambert and Ivan Weir tallied the votes mailed in and those present at the meeting.

Dr. Boyd gave a brief description of a grant program that was being discussed by the Board of Directors that would fund additional programs besides those funded with promotional funds to the states.

Ralph Pulfer, Amanda Milliken and Beverly Lambert were presented plaques from ABCA for serving as Directors in the past.

Dave Arnold gave a report of the Directors' visit to the ABCA office in April. He shared some of the experiences and opportunities that they participated in while visiting which included registration, filing, answering the phone and trying to read other's handwriting on applications.

Patrick Shannahan then presented medallions to Florence Wilson for being the 1996 breeder of the Open and Nursery Top ABCA registered dog. Similar medallions and \$500 checks would also be given to the 1997 winners.

Sally Lacy then introduced Dr. Aclund who had been conducting a free eye clinic sponsored by ABCA during the finals. They announced that he had examined nearly 300 dogs and had obtained much needed, valuable information in helping determine the facts about CEA and PRA in Border Collies.

Beverly Lambert then gave the results of the election of Directors. The following directors were elected to serve 3-year terms: 1) Florence Wilson, 2) Leroy Boyd, 3) Bill Berhow, and 4) Bruce Fogt.

Sally Lacy then gave a report on the proposed investment plan for ABCA. There was much discussion and questions and more details would have to be worked out by the Directors prior to any investments.

The financial statement was also presented and approved. Amanda Milliken then gave a brief report about the status of the Canadian registry. She stated that they hoped to be registering dogs in the very near future. She stated that ABCA had given them \$5,000 to help them get started and had agreed to process their applications for at least 2 years for \$2.50. There was still a problem to be resolved involving their Section B dogs which were not eligible for registration through ABCA.

Next, Alasdair MacRae asked for the opportunity to address the members. He asked for their support in taking disciplinary action against one of the USBCHA's members. After much discussion, it was referred to the ABCA Trials Committee to consider any action that needed to be taken by ABCA on this matter.

As the last item of business, Lyle Boyer made a motion to have two dates available to request promotional funds. It was agreed that they would be February 15 and July 15 of each year. There being no further business, the meeting was adjourned.

Canadian Border Collie Association

The Canadian Border Collie Association is now in full operation in Canada. The ABCA office has processed over 80 registrations for the Canadian Border Collie Association.
