## EILEEN STEIN- 2017 HALL OF FAME INDUCTEE

Mark Billadeau, longtime member of the ABCA Health & Genetics Committee and now one of the current Directors of the ABCA Health & Education Foundation gave a heartfelt presentation for Eileen Stein, this year's recipient of the American Border Collie Hall of Fame. Mark noted the accomplishments of many Hall of Fame recipients have been well known mostly because of their high profile trial performances. But he went on to say there are other important ways of earning the honor of ABCA Hall of Fame recipient and in those ways this year's recipient has clearly

shown her excellence. Her decades of time and tireless dedication to preserving and promoting the working Border Collie, and efforts to improve the health of our breed have mostly been behind the scenes. However she will be well known and recognized for these exceptional efforts by many.

Mark citing Eileen's numerous accomplishments chose a few to share with us and those included:

Eileen was President of the US Border Collie Club for 20 years. This organization was formed in 1975 to resist recognition by the AKC, promote preservation of the working ability, and to educate the public about the breed. Back before FaceBook, the US Border Collie Club brought us the Border Collie Boards Internet Forum. Eileen has been and continues to be the Administrator of the BC Boards, has provided financial support for this site, and has created and fostered content that supports

and educates the public on the working Border Collie.

Eileen became an ABCA Director in 2003 and has served a total of 12 years; 4 of those years as President. While President she oversaw the smooth transition from the original to the current Registrar of the ABCA, a major accomplishment. She has been a member of the Health & Genetics committee since 2003. As a reference point in

time, 2003 was right after Optigen launched the CEA test. As the first major DNA genetics test for working Border Collies, careful integration of this test into a useful tool for breeders and buyers while preserving the diversity of the working gene pool was an extremely delicate and important task. Eileen was part of the team

educating breeders and establishing the ABCA's guidance for the use of this test.

As an Open Handler for about 20 years she knows the importance of the Finals and just like this year, Eileen has traveled to most of the Finals to work at or run the health clinics provided by the ABCA; starting when they were eye clinics and now with the BAER clinics.

Eileen has also been involved with 6 breeder investigations

for fraudulent registrations; these investigations were needed to help preserve the integrity of the pedigree information, which is the central purpose of any registry. This included onsite investigations of DNA samples 3 kennels. needed to be collected at these kennels and at other locations to prove the registrations were falsified. As a lawyer, Eileen understands the demands for proof and was willing to endure the depressing and sometimes dangerous task of visiting these kennels.

Eileen has willingly provided free legal advice to the ABCA and the USBCHA for a number of issues over the years.

Eileen's most recent accomplishment was the establishment of the ABCA Health and Education Foundation, a 501C organization. She recognized we needed a means by which others besides the registry could

fund health studies and education efforts. She established and arranged the effort to get this organization started and obtained seed money for the ABCA to get it off the ground. Eileen is a founding Director and the current President of the ABCA HEF Foundation.

The crowd gave a standing ovation to Eileen Stein, sharing their admiration for such a well deserved honor.

## ANNUAL MEMBERSHIP MEETING BELLE GROVE PLANTATION, MIDDLETOWN, VIRGINIA SEPTEMBER 28, 2017

Mike Neary welcomed everyone to Belle Grove Plantation, Middletown, VA and called the meeting to order.

Debbie Bailey presented proof of mailing of the notice for the Annual Meeting. Debbie stated 2,126 ballots mailed to eligible voters, 12 ballots returned undeliverable. Patricia L. Smith, CPA, tallied the ballots and report 368 validly cast ballots.. This represents more than a quorum of 10% of eligible voters. The results of the election; 4 Directors were elected for 3 year terms; Eileen Stein, Jamie Spring, Bridget Strang and Kathy Knox.

The minutes of the 2016 Annual Meeting were distributed to those in attendance. A motion was made by Dennis Gellings to approve the minutes as presented. Stephanie Goracke made the second and the motion was approved.

Mike Neary gave the President's Report. Mike stated that for the 4th straight year, registrations have exceeded 14,000 and transfers have increased. ABCA registered the 450,000th dog during 2017 since its inception in 1983.

In 2017, the Board approved the expenditure of \$12,705 in Promotional and Educational Funds to local and state organizations and individuals for working Border Collies events. These funds are provided by the earmarked \$1 per dog registered per state or province.

Mike also reported ABCA made available a new website for members to help them with their needs. Special thanks to Warren Mick and the Communications Committee for all their hard work on this project. It was sorely needed and they did a wonderful job on making it happen.

In 2017 the Board approved a total of \$42,804 to sponsor the National Sheepdog Finals and the National Cattledog Finals. ABCA is the longest tenured and most dependable sponsor of both events. Funds have been allocated for livestock expenses, prize monies, and general support. The Board of Directors also approved the expenditure of \$4,500 to support the live webcast of the 2017 National Sheepdog Finals.

In further business the Board of Directors approved changes in the fee structure and fees charged for ABCA transactions starting in January of 2018. The major changes were to eliminate differing prices for cash versus credit, and increase the fees slightly for Registrations, Transfers, Annual and Life Memberships (fee schedule detailed in newsletter, new forms for 2018 enclosed).

The fee change on transactions also allowed the Board of Directors to approve an increase in Promotional Monies earmarked for states and provinces from \$1 per dog registered to \$2 per dog registered. This should help members with their worthy activities that occur at a local level involving working Border Collies.

Mike noted there had been one disciplinary action as of September 2017. Tim & Julie Popplewell, Bakersfield, CA have been suspended from all ABCA member privileges for five years for submitting forged and falsified applications and documents. Furthermore, once the five year suspension has been served, their membership privileges may only be reinstated on a probationary basis for a further five year time period.

The Financial Statement was distributed and presented. After brief discussion, Eileen Stein made a motion to approve, and Peg Anderson seconded the motion. It was approved.

Eileen Stein provided a review of the year for the ABCA Health & Education Foundation. (The report can be found in this newsletter).

Mike Hanley and Peg Anderson Co-Chaired the Hall of Fame Committee. Mike Neary announced Eileen Stein is this year's Inductee to the ABCA Hall of Fame. Mark Billadeau gave the induction highlighting Eileen's many contributions to the working Border Collie breed (details can be found in the newsletter).

Mike Neary asked if anyone had comments or further business. There being no further business Bruce Fogt moved to adjourn the meeting and Stephanie Goracke offered the second. Motion was approved.

- •Tim & Julie Popplewell, Bakersfield, CA have been suspended from all ABCA member privileges for five years for submitting forged and falsified applications and documents. - •ABCA membership was revoked by a vote of the Board of Directors for John Christopher Knight for conviction of crimes of moral turpitude. Effective September 17, 2017.

# HEALTH & EDUCATION

#### REPORT ON THE ABCA HEALTH & EDUCATION FOUNDATION -- SEPT 2017

The ABCA Health & Education Foundation was formed two years ago. Since that time, the HEF has moved forward in establishing itself as a viable organization and beginning work on its programs.

At the HEF's first Annual Board of Directors Meeting, held in October 2016, the five incorporating directors were elected to continue as directors, serving staggered terms. A sixth director was also elected to the board -- Bob Wagner, a cattle rancher in northern Colorado with a doctorate in biochemistry and molecular biology, who is also a founder and current vice-president of the National Cattledog Association.

Our top program priorities continue to be research into Early Adult Onset Deafness, and creation of a databank of Border Collie DNA and health information that could be used for present and future research. We are well on our way with both goals.

During calendar 2017 we voted to sponsor five BAER and sample collection clinics at different trials around the country: Zamora in CA, Fetch Gate in NY, the NCA cattle finals in WY, Meeker in CO, and the USBCHA sheepdog finals in VA. At these five clinics, a total of 301 dogs had their hearing BAER-tested at no cost to their owners. We obtained DNA sample and pedigree information for all of them, so we now have well over 350 BAER-tested dogs with full data. Work continues on our EAOD research project, which is being conducted by Dr. Hannes Lohi of the University of Helsinki in collaboration with Dr. James Mickelson at the University of Minnesota. The entire genomes of 8 Border Collies have thus far been sequenced, and a genetic association study has been completed. Clinical studies are now being prioritized, including additional BAER testing.

Currently, the HEF is on a sound financial footing. As of December 2016, the end of our last fiscal year, we had received \$50,000 from the ABCA, plus several other donations from individuals and organizations, including a couple of major "kickoff" donations. Our 2016 financial statement can be found on the HEF website, **bordercolliefoundation.org.** 

There is still much work to be done on our website. We hope to both enlarge and streamline it over the next few months, but there is enough information there now about Border Collie health and genetics in general, and the HEF and its projects in particular, to make it worth a visit.
